William Wallace, Andrus who has lived near Severance for the past forty five years, quietly passed away at his home Tuesday morning, the 4th day of November. He was born at Aurora, Ill., Aug. 24, 1852 and died November 4, 1924 at the age of 72 years 2 months and 20 days. Mr. Andrus came to Kansas in 1879 and was united in marriage to Miss Cundacy Burrell Dec. 25, 1882. To this union were born nine children, eight of whom are left to mourn the father's death. The one son, Harold, died in infancy.

About thirty years ago he united with the Christian church, remaining a true Christian until his death. He was a loving husband and patient father, and was respected by all for his sincere honesty. Mr. Andrus was an untiring worker even in his later years of life while badly afflicted with rheumatism, he spent his days in patient labor.

Those surviving him are; his wife; three daughters, Mrs. Edith Miller of Moray, Kansas, Mrs. Elsie Simpson of Sparks, and Miss Florence Andrus, who is now teaching at Turton, South Dakota; five sons, Loyd and Henry of Troy, Ernest, Delbert and Carl of Severance; nineteen grand children; besides a host of other relatives and friends.
