Former Wathena resident Mark Shalz delivers vault for Reagan Funeral

When the millions of television viewers were watching the events that preceded the actual funeral and entombment following the death of President Ronald Reagan, June 5, 2004, only a select few knew of a problem that had arisen.

Funeral arrangements for the president had been made several years prior to his death, and it was not until after his death that it was discovered the mahogany casket that had been chosen was not going to fit the burial yault.

The funeral director in charge of the services was a friend of Joe Suhor, president and CEO of the Kansas City Wilbert Vault Co., who was at a convention with regional vice president of the Missouri operations Mark Shalz and they were contacted to see if an appropriate vault could be found. If not, a suggestion that had been made was to place the casket with the former president's body inside the tomb at the Ronald Reagan Presidential Library in Simi Valley, CA without a vault. Mark thought that was not an appropriate burial for a president.

The search found an oversized vault in Marian, IA (outside of Cedar Rapids) Tuesday, June 8. "We had an idea where an oversized vault was located so it only took a couple of hours," remarked Mark Shalz. The vault would be picked up in Iowa, taken back to Kansas City to be painted and then Mark would transport they were in disbelief of the events and were sworn to secrecy on the ordeal. No one was to know of the event, with only a few employees at the Kansas City Wilbert Vault Co. knowing where the vault's final destination would be. When making the trip to California Mark was told that if the vehicle broke down just to go buy a new vehicle, not to wait around for it to get fixed. Fortunately, it did not break down until the return trip home, then they exchanged vehicles at a branch of their company.

Unfortunate for Lester, Executive Vice-President and CFO Dennis Welzenbach decided he would be the person making the 25 hour drive to California with Mark. Lester would be sitting at home, watching the historical event on television, knowing his son would have a part of the famous entombment.

When Mr. Shalz and Mr. Welzenbach arrived in California with the vault, pallbearers were having a practice so everything would go smoothly.

Following the California sunset farewell service for the former president, Nancy Reagan left the premises at 10:45 p.m. When Mr. Shalz came around the corner he was taken aback as Reagan's casket was before him with no one around to guard the casket. "I was very surprised that no one was guarding the casket," remarked Shalz.

A catered meal for 700 had been planned following the

Welzenbach to wipe off the dew. When Mrs. Reagan gave her final farewell to her husband her handprints were left on the casket and when the dew was being wiped off the prints could be seen. "It was eerie," stated Mr. Shalz.

Mr. Welzenbach wanted some of the dirt that had been dug as a memento and had even placed some in his pocket, but was told to put the dirt back. He only replaced half the dirt, so he had a small handful left in his pocket.

At approximately 11:00 p.m. the vault company crew began the entombment process, with Mark carrying the front part of the casket, and his boss, Mr. Welzenbach, carrying the rear of the former president's casket. The underground crypt had been opened and went down 20 ft. to where the casket carrying the former president's remains would be emtombed. Workers closed the underground crypt

shortly before 3:00 a.m., with the landscapers taking over their part of the operation. The only people at the library were a handful of Secret Service agents, library personnel, mortuary representatives and landscapers. Lights were placed around the area with the light shining away from the final resting place, to ensure that the press would get no pictures of what was going on at the time.


Mark commented, "This has to rate as one of the top five events in my life, with my two children being first. I had chills and there were tears in my eyes."

As with any parent, both Lester and Marilee Shalz were extremely proud of Mark. "This is something that you wouldn't expect a small town boy to do. The whole time we were watching on TV we were wondering where Mark was," remarked Marilee.




A catered meal for 700 had been planned following the services, but everyone left, so members of the cemetery crew, vault company and landscaping crew were encouraged to eat the catered meal.


